The stage is set. We are supporting three bills during this 2011 NM Legislative Session. They have each been referred to two committees in the House and the Senate. In the House, those committees are “Consumer and Public Affairs” and “Judiciary.” In the Senate, those committees are “Public Affairs” and “Judiciary.” We will keep you informed as action is being taken on these bills. In the meantime, please contact your representative and senator, as well as members of the above-mentioned committees, and ask them to support these bills.

The three bills being supported by RTLCSNM with their bill numbers (SB = Senate Bill; HB = House Bill) are:

**1. Pain-Capable Unborn Child Protection Act (SB 222/ HB 179)**

Because unborn babies feel pain at 20 weeks development, this bill would ban abortions after that time.

**2. Unborn Victims of Violence Act (HB 30)**

The bill would establish that if a "child in utero" is injured or killed during the commission of certain crimes of violence, then the assailant may be charged with a second offense on behalf of the second victim, the unborn child.

**3. Parental Notification Act (SB 230/ HB 229)**

The bill would require that at least one parent be notified before an abortion is performed on an unemancipated minor.

We are lobbying for the passage of these three bills. However, the best lobbyists are the legislators' own constituents (you!). Even when legislators have a pro-life record, they need to hear from their constituents so that when they support the bill they can give numbers from their district as to who supports their actions.

We don't know where all of the legislators stand. You need to let them know where you stand. You are the one to vote for or against them in the next election. Help them see the will of the people. We are not suggesting using that threat in your letters and phone calls. It is just a reality of what a legislator sees when he/she receives communication from one of his/her own constituents.

When you contact a legislator, it is suggested that you refer to one subject at a time. But this year we have three bills. The best advice is still to **treat each bill as a separate subject in separate letters**. We realize this requires more time on your part, but **this approach offers the best opportunity for your views to be heard on each subject**.

You can communicate with your legislators by various means. The best is to e-mail or send a letter. A phone call is good when time is critical and/or you cannot send an e-mail.

Please know that **committee members hearing our bills do not represent a district when they are on a committee, so all on each committee** should have communication from proliferers. This is especially true when the member is also your representative from your district.

### **THE NATIONAL LEGISLATIVE AGENDA**

Activities in the House and the Senate have begun. The second bill to be introduced into the House dealt with Healthcare Bill H.R. 2 sponsored by pro-life Congressman Eric Cantor (R-VA), who is the House Majority Leader. As of January 12, 2011, 180 Republicans have signed on to this bill (no Democrats as yet). This bill would completely repeal Public Law 111-148, the “Patient Protection and Affordable Care Act” (PPACA) enacted in March 2010, which is more widely known as “President Obama’s Healthcare Law” or “Obamacare.” Both National RTL and The Right To Life Committee of New Mexico are in great support of this legislation.

Cong. Mike Pence (R-IN) has placed a bill in the hopper that would revoke federal taxpayer funding for Planned Parenthood abortion businesses. The Title X Abortion Provider Prohibition Act Bill H.R. 217 ensures that taxpayer money authorized by the federal government for family planning efforts supposedly to reduce abortions doesn’t go to the nation’s biggest abortion business. Last year alone, according to Planned Parenthood’s own annual report, it received more than \$363 million in revenue from government grants and contracts. During the same timeframe, it performed 324,008 abortions, a 5.8% increase from the previous year, which also set a record high. So far 127 Republicans have signed on to this bill and one Democrat. Both National RTL and RTLCNM are supporting this legislation

Pro-abortion legislation has been introduced by Cong. Lynn Woolsey (D-CA). This bill, H. Res. 20, is a House Resolution that urges the U.S. Senate to ratify the Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW). National RTL has opposed the ratification (thus opposes the bill as well), because the CEDAW has been interpreted by certain U.N. panels and other international bodies to condemn various pro-life laws. There are 63 Democrats co-sponsoring this legislation, which does not include Martin Heinrich or Ben Lujan.
